WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

This document includes an assumption of risk and release of liability. Read it carefully before signing.

1. In consideration for receiving permission to participate in the Blackbird 8k (the 'Event'), I hereby release, waive, discharge, and covenant not to sue Brian Moorman PUNT Foundation and their respective officers, directors, servants, agents, and employees (hereinafter referred to as the "Releasees") from any and all liability, costs, expenses, claims, demands, actions, and causes of action whatsoever arising out of or relating to any loss, damage or injury, including death, that may be sustained by me, or to any property belonging to me, whether caused by the negligence of the Releasees, or otherwise, while participating in the Event, while in, on or upon the premises where the Event is being conducted, while in transit to or from the premises, or in any place or places connected with the Event.
2. I am fully aware of the risks and hazards associated with being on the premises and participating in the Event, and I am fully that there may be risks and hazards unknown to me associated with being on the premises and participating in the Event, and I hereby elect to voluntarily participate in the Event, to enter upon the above named premises and engage in activities knowing that conditions may be hazardous, or may become hazardous or dangerous to me and my property. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of my being a participant in the Event, whether caused by the negligence of the Releasees or otherwise.
3. I further hereby agree to indemnify, save, and hold harmless the Releasees and each of them, from any loss, liability, damage, expense or cost that they may incur due to my participation in the Event, whether caused by the negligence of any or all of the Releasees, or otherwise.
4. It is my express intent that this Waiver of Liability and Hold Harmless Agreement (this "Release") shall bind the members of my family, my estate, heirs, assigns, and personal representatives and shall be deemed a release, waiver, discharge of and covenant not to sue the above named Releasees.
5. In signing this release, I hereby acknowledge and represent that:
 - A. I have read the this Release, understand it, and sign it voluntarily as my own free act and deed;
 - B. I am in good physical health and in a condition that will allow me to participate fully in the Event and not under a physicians care for any undisclosed condition that bears upon my fitness to participate in the Event;
 - C. No oral or written representations, statements or inducements, apart from those made in this Release, have been made to me;
 - D. I am at least eighteen (18) years of age and fully competent to execute this Release, or my parent or guardian is signing this Release on the grounds that I am below eighteen (18) years of age; and
 - E. I execute this Release for full, adequate, and complete consideration fully intending to be bound by same.
